

Official Tournament Rules

1) Team Composition:

1.1 Five (5) to maximum fifteen (15) members per team made up of bona fide employees of the Manning Agency/Organization and its Affiliate companies. Five (5) Players to Play, composed of at least **ONE (1) female** bowler playing at any given game.

1.2 No changes to the Team composition will be allowed after the start of the Tournament

2) Handicapping:

2.1 Handicap shall be **80%** of the difference between the bowler's average and the base of **160 for Male and 140 for Female** and shall be floating throughout the duration of the elimination round. Handicap of a player will be computed after he/she has completed 3 games. All bowlers are required to have played at least 3 games after the 3rd playing date. A bowler who has not completed 3 games after 3 playing dates will not receive a handicap until he/she has completed 3 games and Handicapping will be applied on the 4th Saturday.

2.2 On the 1st 3 consecutive Saturdays, **Zero handicap** will be applied to the scores, HOWEVER, the average Handicap computed on the 4th game date shall be applied on the 1st 3-games, retrospective of the scores.

2.3 Maximum handicap is **30** for men and **40** for women.

2.4 Rules on "Sandbagging"

Once the handicap has been established, after completing the initial 3 games he/she can only **go up** to a maximum of **3 more** pins handicap.

2.5 Final Handicap during the Elimination round will be carried over, and shall be fixed on the Championship round.

2.6 **No handicap during Master's Competition for Males and Females.**

3) Game Format -

3.1 The top 50% of the Teams with the highest number of pin falls during the **Elimination Round** will compose the **GROUP "A"** and advance to the Championship Round wherein they will play 3 games. The team with the highest pinfalls including handicap, will be declared Champions.

3.2 The remaining Teams that did not make it to the top 50% shall compose the **GROUP "B"** and will also play 3 games during the Championship Round and the

team with the highest total pin falls including Handicap shall be declared Consolation Round winner and will also receive a trophy.

3.3 Scoring and Lane assignments will be handled by the organizers PAMAS, in close coordination with the Tournament Committee members.

3.4 Only the **1st Game** and **Championship Game** lane assignments will be raffled.

3.5 Schedule of Elimination and Championship Games as follows:

1 st to 3 rd Game dates -	Actual pinfalls count for Handicapping
4 th to 5 th Game Dates -	Elimination Games for "A" & "B" Grouping
6 th to 9 th Game Dates -	Championship Round, All teams back to ZERO
9 th Game Date -	Masters Competition
10 th Game Date -	Championship Games

4) **Blind Scores and Default:**

4.1 A team with less than 3 bowlers after the first player of the opposing team has thrown his/her 1st ball of the fourth (4th) frame will be considered default. The opposing team will continue to play and will be credited points accordingly.

4.2) A player who arrives late can still play provided he/she arrives before the first player of the opposing team throws his/her (1st) ball of the fourth (4th) frame.

4.3) If a Team has only 3 or 4 bowlers playing, a fixed score of **fifty (50)** will be given to a missing player, or blind lane.

5) **Master's Competition:**

5.1 Each team will be represented by five (5) players only (Lane fees are included) in excess of five (5) players per team, such Team will shoulder the lane fees.

5.2 Those vying for the Individual Male and Female Master's Competition must have played at least 50% of the total number of games of the elimination round. The top Male and Female bowler with the highest total Pin falls score for three games shall be declared Champion.

6) **GAME TIME:**

6.1) Shadow bowling will start at exactly **1330** hrs

6.2) Roll off will start at **1400** hrs

6.3) Bowling Center time will be the official time.
