We are delighted to share with you a message from the Chairs of the Maritime Industry Crew Change Taskforce.

Dear Signatory to the Neptune Declaration,

The crew-change crisis has been ongoing for over fifteen months and the situation is getting worse, not better. The deterioration since last month is driven by the continued rise in Covid-19 cases and the spread of new variants in important seafaring nations. This has led to increased government restrictions in important crew change hubs, which has limited the opportunity to perform crew changes, especially in Asia.

This puts the seafarers, who are key in supporting global trade, in an unacceptable situation and this also poses a larger threat to the resilience of global supply chains. There is an urgent need to keep up our efforts to address the crew-change crisis.

This will require governments to allow crew-changes to take place and collaboration across the value chain, not least between shipowners and charterers, to ensure that necessary crew changes can be carried out, with the least impact possible in terms of cost and delays.

Importantly, resolving the crew change crisis will require seafarers to have access to vaccines and to be allowed to travel based on their vaccination status. While international seafarers have started to get access to vaccines, for instance in the US and in parts of Europe, the vast majority of seafarers, especially from developing countries are still unable to be vaccinated due to shortages and inadequate vaccination structures.

We have a responsibility as a global community and as the Neptune Declaration community to take action to protect the seafarers who play a crucial role in difficult circumstances, being far away from friends and family.

We have provided further updates on the Neptune Declaration action areas in the attached slides and we will continue to keep you updated on developments and on ways through which you can help support the next steps.

Neptune Declaration July Update

The Neptune Declaration
on Seafarer Wellbeing
and Crew Change

Key Developments

- The latest Crew-Change Indicator shows a significant increase in the number of seafarers onboard beyond expiry of contract as numbers have risen by over 50% over the past 2 months.
- The number of Covid-19 cases remain high in key seafaring nations, such as India and the Philippines.
- In response, travel and local restrictions have caused disruption to crew movements and complicated crew-changes.
- A decrease in the number of flights and further travel bans has made it harder for seafarers to join vessels or go back home.
- Some seafarers are starting to get vaccinated, especially in the US and in parts of Europe, but access to vaccines still remains a serious issue.
- The use of 'no-crew change' clauses or similar provisions continues to complicate crew changes.
- In early June, the ICS issued [Guidance for Ship Operators for the Protection of the Health of Seafarers, Third Edition](#) to help shipping companies and seafarers follow health advice provided by UN agencies in response to Covid-19.



Seafarers' Access to Vaccines

- Ensuring seafarers have access to vaccines is a long-term solution to overcome the crew-change crisis. Recent developments include:
 - In the **United States**, vaccines have been offered to international seafarers in more than 70 ports. NAMMA has compiled a list of North American ports offering vaccines for seafarers: [COVID-19 Vaccines for Seafarers \(namma.org\)](https://namma.org).
 - Vaccination campaigns for national and non-national seafarers are also being implemented in **Europe**. The Netherlands, Germany, Italy (for national and potentially for non national) and Belgium are for instance following the USA's example and offering vaccinations to seafarers calling in their ports.
 - **India** has also begun offering vaccinations to seafarers as key workers and there has been work to set up quarantine, testing and vaccination centres in Chennai and Mumbai.



Seafarers' Access to Vaccines

- However, seafarers continue to have **limited access to vaccines** as lack of vaccine supply is also a challenge in many key seafaring nations. In the Philippines, industry partners have set up facilities for quarantine, testing and vaccination but the lack of vaccinations affects this structure.
- Despite being vaccinated, some seafarers still face **travel restrictions**. Some countries require certification of vaccination or electronic proof of it. There are also issues with the types of vaccines administered and their recognition.
- The ICS, ITF and other organisations continue to actively work with international governance bodies to further secure seafarers' access to vaccines. There is for instance conversation with Cyprus of the potential development of a vaccination hub.



The Neptune Declaration Crew Change Indicator

- The latest Indicator was published on 1st July, showing a resurgence in the number of seafarers who have been onboard past the expiry of their contracts.
- Since the Indicator was first published in May, this percentage has risen by 51,7% and is based on data shared by the 10 largest ship managers. This rise from 5,8% to 8,8% reflects the deteriorating crew-change situation.
- The number of seafarers who have been onboard for over 11 months has also rise from 0,4% to 1%, corresponding to a 150% increase.
